

PROCEDURE OF PURCHASE

1. Submit to www.focusgreece.com/sales
2. Go to your coupon of interest
3. Click in BUY COUPON
4. Select the method of payment in the bottom of the page
5. Proceed to the payment of the Coupon Cost (10 euro or 25 euro or 50 euro depending of the 'to the supplier' (Read at the Concepts / Definitions area below).
6. Pay at the hotel or hostel or the Supplier the Discount price 'to the supplier' to receive the Package details.

Website: this website «www.focusgreece.com/sales»,

Suppliers: Supplier means any third party vendor who uses the company's website to provide / sell their products / services at special discount prices to users / subscribers of this website.

Product / Service: product / service from the suppliers is available at a special discount price (package cost) through the website,

Buyer: each registered user / subscriber who participates successfully buying discount coupons posted on this website and buy the product / service from the Suppliers.

Coupon: The document is available electronically through the website to the Buyer, each coupon that is bought by the Buyers has a unique code and will be received after payment to the buyers email or fax if he contact our NOVASOFT FOCUSGREECE company and should be compulsorily submitted by the Buyer to the Supplier to receive the product / service paying additionally to the Supplier the discount 'Package cost' that is described on each coupon page.

'to the supplier': The rest of the coupon cost that you have to pay to the supplier in order to get your discount coupon details,

Pay in Advance: is clearly shown during your payment and is payment in advance 10 euro for payments till 499 euro discount packages offers, 25 euro from 500 euro till 999 euro discount packages and 50 euro for discount packages above 1000 euro and you will see it during the payment method procedure. Only for payments with bank deposit you should pay additionally the transactions fees.

Package Cost: Package cost is the totally discount price that is shown in the Package Cost area of the coupon page (He will receive it in his or her email exactly as shown in the web page www.focusgreece.com/sales).

Terms of Services

1. Each user / subscriber can buy discount coupons that has been posted on the website paying the 'in advance' cost and can use them for third parties (family and friends as a gift) using accepted payment methods that are valid during the transaction procedure and additionally the package 'to the supplier' cost must be paid to the supplier to get the coupon package details.
2. The discount package coupon content is coming straight from tourism professional or suppliers (hotels, rooms, camping, etc) and for each discount coupon there is signed a contract between our company NOVASOFT FOCUSGREECE and the suppliers and is available to any user that has bought the coupon of his interest (if needed).
3. All the coupons describe exactly the facilities and the period of time that are valid and of course the package details.
4. Payment methods are bank deposit, Use of Pay Safe cards, visa and master cards and Paypal procedure. I bank deposit the buyer is must pay also the transaction fees and without paying the transaction fees we have not any obligation against him or her.
5. If any person buys the coupon not any obligation is coming if he does not use it.
6. Also the buyer cannot have his or her money back (concerning the in advance payment) if he buys the coupon and not any obligation has our company against the buyer if he does not use the coupon.

Additional Terms

1. The Company through its website enables suppliers to promote their products / services to users / subscribers (Byers) of our company NOVASOFT FOCUSGREECE websites at special discount prices for a specific time and / or quantity and period, defined any time in the respective offer description that has been posted on the website and under the terms and conditions described in each package details.
2. The Company will make available to users / subscribers / Byers who successfully participate to buy the discount packages coupons via the website online. By showing the coupon to the Supplier, as described below, the user / subscriber / Buyer is entitled to receive from the vendor product / service which this discount package attended and described exactly in each sales location (package details) and paying for that (showing the coupon to receive the service or product) the discount **package cost** showed in his coupon and website when he receive the service or product.

Payment Method

The payment for the product / service is via pay safe cards, via PayPal procedure, via credit card or bank account evidenced by fax at +302310385582 (after sending the deposit document of the amount that has been deposited by fax and all the necessary data of the buyer, in order to activate the voucher within one working day). Transactions of users / subscribers to the site are protected by maximum online security systems (digital certificate encrypted with SSL 128-bit, control of three-digit security code of credit card (CVV), additional security systems online transactions such as Verified By Visa™ by Visa® SecureCode™ or the MasterCard®), which guarantee a secure environments.

Description and Conditions for Payment by Credit Card

1. The user / subscriber express interest in one or more offerings by providing credit card information. Time the purchase of a Bid is defined as when the user / subscriber press the button "Buy Coupon".
